Each year USA Gymnastics awards the silver quill award to the best state USAG newsletter in the nation and this year added an award for the best state web page. Compulsory Elements Out of Order *by Marian Dykes, RTCC*

If a JO athlete omits a major element in a compulsory exercise and then performs it later (out of order) or at the completion of the routine, the deduction for deliberate omission will be applied. The element is not to be evaluated, except in the case of a fall, for which a 0.50 deduction will be applied. Once the deduction listed above is taken it is as if the skill does not exist. Do not take a second omission deduction for the same occurrence.

The following examples may help understand this new rule.

Level 5 Beam:

Routine 1 - Gymnast does the routine in the following order:

Mount, backward swing turn, Cross handstand, 1/2 turn, arabesque scale, arabesque, straight leg leap, 1/2 squat turn, cartwheel, 1/2 pivot turns (L&R), straight jump, straight jump, split jump, cartwheel dismount

No deduction - all elements done in order

Routine 2 - Gymnast does the routine in the following order:

Mount, backward swing turn, Cross handstand, 1/2 turn, arabesque scale, arabesque, straight leg leap, 1/2 squat turn, 1/2 pivot turns (L&R), two straight jumps & split

jump, cartwheel dismount — gets back on the beam and does the cartwheel

The routine is considered ended with the dismount. The cartwheel is considered changed or omitted — deduct 1.00 + 0.80 (the value of the element) = 1.80 total deduction, do not take execution for the cartwheel since it is considered omitted but take a fall if it occurs on the cartwheel. The time ends with the dismount; do not restart the time or take any execution deduction for getting back on the beam. The only deduction would be for a fall if it occurs on the cartwheel.

Routine 3 - Gymnast does the routine in the following order:

Mount, backward swing turn, Cross handstand, 1/2 turn, arabesque scale, arabesque, straight leg leap, 1/2 squat turn, cartwheel, 1/2 pivot turns (L&R), straight jump, split jump, straight jump, cartwheel dismount

One of the straight jumps are out of order, therefore changed or omitted — deduct 1.00 + 0.40 (the value of the element) = 1.40 total deduction, do not take execution on the second straight jump since it is considered omitted, but take a fall if it occurs on the second straight jump.

Have a great compulsory season.

Region 8 Again Performs New Skills at JO Nationals

Region 8 has a national reputation for new and original skills at the Junior Olympic level. Once again Region 8 had original skills performed at J.O. Nationals for the first time. Two gymnasts from Region 8 competed never before seen skills at Level 10 J.O. Nationals in May. Because of their originality, these skills have been added to the USA Gymnastics J.O. Supplement and will carry the name of the gymnast performing them.

North Florida Gymnastics **Beth Bronson** performed Bounce-back/Tanac 2/1 - from a cast, uprise or backswing, straddle cut to salto backward tucked or stretched with 2/1 twist or more on LB or HB. This bar skill will be called a **Bronson** with a "D" value. On balance beam, **Rheagan Courville** of *Elite Gymnastics* performed a split leap with leg change to cross split (over 180° split) and backward bending (arch) of upper body with head release (Switch-leg Yang Bo). This dynamic leap was awarded an "E" value.

Congratulations to these outstanding Region 8 gymnasts.

Region 8 Represented at Olympic Trials and 2004 Congress

Region 8 was well represented in Anaheim at the Olympic Trials and at the 2004 Congress.

At Olympic Trials, **Melanie Sinclair** of *Orlando Metro* in Florida was impressive. Melanie was accompanied by her coaches **Jeff Wood** and **Christy Bearenau**. The competition was judged by **Lucy Fox** of Region 8. In addition Lucy was honored as a member of the 1984 Olympic Team on their 20 year anniversary.

Several Congress lectures were presented by Region 8 representatives including **Paul Padron**, **Brad Harris**, **Chris Calvert** and **Marian Dykes**. In addition to presenting his own lecture, Paul Padron provided all of the hardware enabling the audience interactive participation in evaluating the videos at several lectures.

Deb Kornegay and **Kim Boyd** worked throughout the Congress on the administrative side helping the "Congress Team" manage sessions. Way to go Region 8!

Sanction Violations - What Do I Do?

What happens when there is a meet that breaks a rule listed in the Rules & Policies? Most Meet Directors would be surprised that rules violations are often reported in writing to the State or Regional Committee Chair even if the person reporting is not comfortable enough to list the problem on the sanction form. Every Meet Director must be familiar with the many meet rules and guidelines in the Rules and Polices. Here are several of the rules that are often seen broken:

- ◆ Number of gymnast in the session. There is no provision to allow more than the number of gymnast listed no matter what the circumstances.
- ◆ Athletes cannot be on the competitive floor for more than 5 hours. Be careful to design the meet schedule to allow for rotating, judging and even a stop in the meet due to an unexpected occurrence such as a lengthy fall, music breaking, etc.
- ◆ Meets should finish by 10:00 p.m. Be sure and allow time for march in and to march from event to event.
- ◆ Judges must have breaks. Your schedule should provide a minimum of 30 minutes after 3 1/2 - 4 hours of judging time and a minimum of 45 minutes after 7 hours of judging time.

Gymnastics is such a close community, most professional members request that complaints they lodge be kept confidential. Every effort is made to make all levels of the investigation confidential. With this in mind, all sanction violations are taken very seriously. A list of penalties for sanction violations can be found in the *Rules and Policies*.

Meet Directors are encouraged to read their *Rules and Policies* and be familiar with it. This book was designed with the combined efforts of many experienced coaches and judges. The rules listed in the R&P will help make your meet a fantastic experience for all.

As a coach or judge, please report any sanction violation to **RACC, Debby Kornegay**, or your **SACC**, by e-mail or mail. Addresses for e-mail and mail are available on the back page of this newsletter.

As a meet director, please be reminded that Sanction Rules are in effect for the safety of our athletes and any violations could result in warnings, fines, revoking of current sanction or denying sanction for future events.

Technical Notes

The Region 8 USAG Committee will continue to make regional assignments in the summer. The USAG Region 8 Committee at their summer meeting made assignments for both 2005 regional championships. These assignments can be found in the minutes in this newsletter as well as on my web page.

In gym experience cards for regionals 2006 have already been sent. These cards were sent to all Level 10 and higher judges that submit a regional availability for 2005. These cards can be completed using in gym experiences from June 16, 2004 - June 1, 2005. This June 1 due date is a date received. Please be sure you meet this firm deadline. Any Level 10 or higher judge must complete this card to be eligible for consideration by the Region 8 Board for assignment to a regional meet in 2006. If you did not receive a card, you may print one from my web site or contact Marian Dykes.

Availability forms for Regional Championships are in this newsletter. You will **not** receive an individual mailing. Completed forms must be returned to Marian Dykes by June 1, 2005. Many questions continue to arise regarding regional assignments. The following items may help clarify this procedure.

1. Your USAG Region 8 Board will make Junior Olympic regional assignments. Please remember the requirement for **IN GYM EXPERIENCE**. Please remember that an Active Status must be on file with JCI.
2. Please remember your **IN GYM EXPERIENCE** must be at the level of meet you wish to qualify for assignment to. For example, to satisfy the requirement for Level 9/10 regionals, **IN GYM EXPERIENCE** must be at Level 10 or higher.
3. Your USAG Region 8 Board will make recommendations from Region 8 for Level 10 J.O. Nationals and Level 9 J.O. Easterns. If a judge does not satisfy the current elite active-status requirements as well as work at one of the Region 8 training camps, they will drop to the bottom of the rotation for Level 10 Nationals and Level 9 Easterns and will therefore be ineligible for the year.

Clarifications for the 2004-05 season include the following:

- ♦ **COMPULSORY** - If a JO athlete omits a major element in a compulsory exercise and then performs it later (out of order) or at the completion of the routine, the deduction for deliberate omission will be applied. The element is not be evaluated, except in the case of a fall, for which a 0.50 deduction will be applied.
- ♦ **FOR INJURY PETITIONS PROCEDURES** - If a gymnast completes all four events at the qualifying meet, she is not eligible to petition and advance to the next competition.
- ♦ **TIMED WARM-UPS** - When using a modified warm-up procedure, an adult monitor (not the judges) must be assigned to regulate the number of athletes on the floor at onetime and to keep track of the competitive order.
- ♦ **CELL PHONES USAGE** - All individuals involved in the competition "field of play" are required to either turn off their cell phone or set it at vibrate mode during competition. Any calls should be made outside the field of play. This applies to coaches, judges, volunteers and athletes.
- ♦ **EMERGENCY CANCELLATION BY A JUDGE** - As a professional courtesy, if a judge has to come off a meet due to personal emergency and he/she has an airline ticket, he/she should work with

- ♦ the airlines to try to recoup the airfare either through a refund or paying a change fee to use the ticket for themselves at a later date. If any money is recouped, the Meet Director should be refunded.

Please visit www.usa-gymnastics.org and checkout, "What's New for the Women's Jr. Olympic Program in 2004-2005," Connie Maloney, USA Gymnastics Women's Jr. Olympic Program Manager for all 2004-05 changes.

All judges will be required to recertify in 2005. In June of 2005, new compulsory routines as well as new Optional rules for the next cycle will be presented at the Master Compulsory Workshops and Technical Symposiums. **The present Compulsory rating is valid through December 31, 2005.** All judges will be required to re-certify for the new Compulsories (for the 2006-2013 cycle) by passing a written exam. Optional judges will also be required to recertify by passing an exam. The following schedule has been announced:

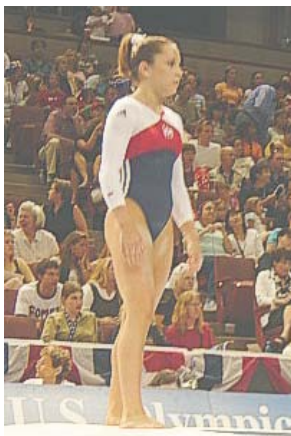

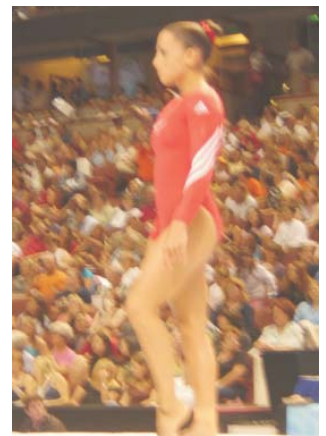

Score Changes for TOPs and Juniors to Qualify to Challenge for the 2005 Season:

Compulsory score to TOPs will increase to 31.00 AA
Optional Score for Jr. Pre-Elite will increase to 32.00 AA

TOPS:

Testing has concluded in our region. Athletes will be notified in late August or early September if they have qualified to National TOPS testing in October. All results will be sent to the clubs.

National Tops Testing:

Please remember that at the National testing, athletes will be tested on the Skills as well as physical abilities. We have made changes in the National routines and these changes **WILL** be in effect for this season so please take the time to go to the National TOPS website at USAG and get a copy of the routines with the changes. The changes have been minimal, however, you will need to know them in October.

Pre-Elite Testing Manual:

Elite/TOPS Clinic:

Due to low registration numbers we have cancelled the clinic scheduled for September in Atlanta for the TOPS athletes.

Elite/TOPS Clinic:

On December 18 & 19 we will have our annual Elite clinic and a TOPS clinic at American Twisters in Coconut Creek, Florida. **Tammy Biggs** from the USA National staff will be a clinician along with Coaches/Judges from our region.

TOPs Coordinators:

Our committee is working on a restructure of the TOPS program in an effort to bring it to the State level to encourage more club participation. As soon as everything is official, information will be included in newsletters and the website.

Elite Qualifiers:

Pre elites and Elites in our region will need to qualify to the Challenge or Classics by attending any of the National Elite qualifiers or the regional International qualifier that the region will host in July. The region will not offer a winter Regional competition this season as we have one of the National qualifiers in our region and that will serve as our regional qualifier. Athletes may attend as many of the National qualifiers as they wish.

Athletes Qualified to Classic:

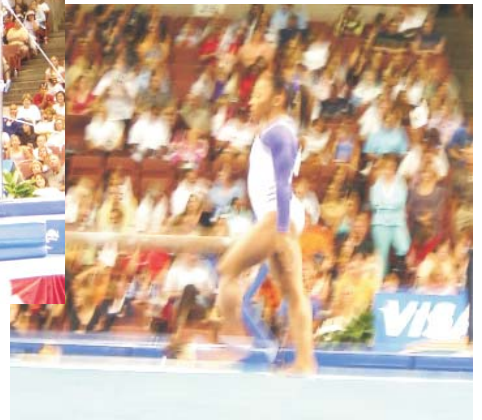

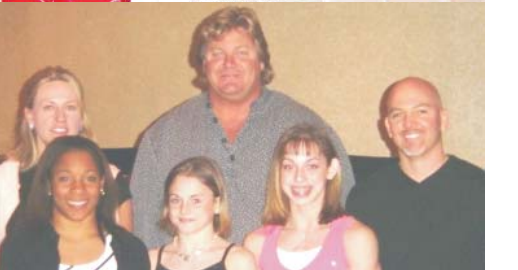

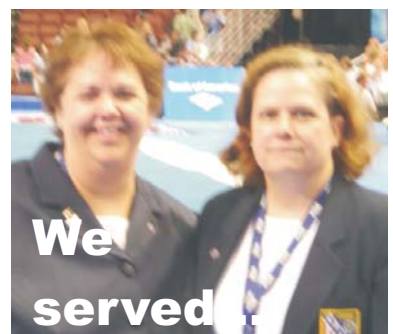

Latest Technique has updated National information for judges' recertification. Marian encouraged all SACC's to financially help recertifying Brevets when able. Brevet course will be held in Feb. 2005. The registration fee has not been announced.

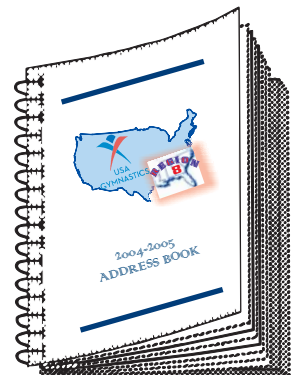

Compilation of Region 8 USA Gymnastics Committee Minutes

Prepared by Marian Dykes, RTCC

Revised 6/2/04

JUNIOR OLYMPIC PROGRAM

The JOCC will form a Regional JO Committee. Each state must appoint one person for the JO Committee. Brad Harris will serve as Assistant JO Chairman and will work with Paul Padron to setup and administer Training Camps. (7/3/02)

The WTC is encouraging the flashing of Start Values at all Level 8, 9 & 10 competitions. (7/3/02)

STATE MEETS

Base score video were discussed. SACC's must mandate the use of base score videos at Level 8, 9 & 10 State Meets. (7/3/02)

SACC's were reminded to have judging selection for Optional State Meet to Marian Dykes, RTCC by November 1st of each year. (7/3/02)

Region 8 strongly recommends that each state use 4-judge panels for all state championships. (12/20/02)

Region 8 USAG Committee suggest the Optional State Meet entry fees, set by USAG State Committees, not exceed \$75, with consideration to facility, equipment, judging expenses and awards. (10/18/99) (12/20/02)

Regional Meet entry forms should be Xeroxed (copied) from form. Four copies should be made:

1 to RACC, 1 to RTCC, 1 for Meet Director, 1 for State Chair to keep. (12/18/99)

Regional Meet entries must be paid with one club check. Individual checks cannot be used. (12/18/99)

ELITE REGIONALS

If a gymnast's Regional Meet entry is NOT turned in by deadline date, in order to enter the gymnast(s) in the Regional Meet, the following penalty will apply to the coach:

- A \$25 late fee per gymnast (in addition to the regular entry fee) must be paid to the Regional Meet Director.
- \$200 fine payable to Regional 8 USA Gymnastics for each meet involved.
- Fines must be received prior to training day (6/7/00)

REGIONALS

The Level 8, 9 & 10 Regional entry fee be \$85 because of the required use of outside facility, air conditioning, equipment rental, and regional representation of judges. (7/27/01)

The Meet Director will pay a fee of \$10 per athlete from all Regional Championships to the regional account. (7/27/01)

Region 8 will pay half the cost of awards at Level 9/10 Regional Championships, the other half to be paid by the Meet Director. The Level 8 Meet Director pays the entire awards expenses. (7/27/01)

Region 8 will give all-around awards to 33% of competitors at Level 8, 9 & 10 Regionals, or at Level 10 to all athletes qualifying to Nationals, whichever is greater. (7/27/01)

All graduating seniors at Regional Meets will be presented with flowers by the region. (1/4/97)

If a gymnast's Regional Meet entry is NOT turned in at the State Meet, in order to enter the gymnast(s) in the Regional Meet, the following penalty will apply to the coach:

- A \$25 late fee per gymnast (in addition to the regular entry fee) must be paid to the Regional Meet Director.
- A \$200 fine payable to Regional 8 USA Gymnastics for each meet involved.
- Fines must be received prior to training day (6/7/00)

Injury petitions are accepted for Level 9 & 10 regionals. All petition information along with the entry check still must be sent to Marian Dykes, RTCC with a copy to Paul Padron, RJOCC. A regional Entry Form will be published in the Winter Region 8 Newsletter and will include a place for petitioned gymnasts. (7/3/02)

The RACC will do the draw for Level 8,9 & 10 Regionals by computer program before open workout day and post the draw on the Region 8 web page. (7/9/03)

Maximum gate fees are \$10.00 Adults, \$5.00 students and 5 and under free. Gate entry charges should be included in pre-meet information. (7/9/03)

Region 8 Committee strongly recommends that judges assigned to Regional Championships wear official NAWGJ uniform and that females wear skirts and men wear ties. (7/9/03)

LEVEL 8 REGIONALS

The number of gymnasts at Level 8 Regionals All Stars is 208 + all ties + an additional 54 athletes. The number of team members is 64 (8 per state with 5 scores counting for team). There are no petitions accepted to Level 8 Regionals. The additional 54 athletes are determined by a percentage of those scoring a 34.00+, by the designated deadline, from all 8 states. (6/7/00) (12/19/03)

A foreign athlete is eligible to compete as an all star at Level 8 Regionals as long as an additional gymnast from that state is accepted to Level 8 Regionals. The foreign athlete would receive duplicate awards at Regionals. Foreign athletes would be in addition to the percentage Level 8 numbers for each state. Foreign athletes cannot qualify on a state team. (7/3/02)

If a state does not have sufficient athletes to fulfill allotted spaces on state team at Level 8 Regionals, RACC will notify all-star with the highest All Around score from all State Meet results to fill available slots. (6/30/99)

Level 8 all-star alternates will be placed in any slots that become available up to forty-eight hours prior to the start of warm-ups of the first session of competition. (6/30/99)

Level 8 team alternate will be placed in any slots that become available up to the start of warm-ups of the first session of competition. (6/30/99)

All regional teams will receive plaques at Level 8 Regionals. The plaques will be presented prior to the team competition as the official state photograph is taken. The teams finishing first through third will receive additional tabs to attach to the plaques reflecting their respective finishing positions at the awards ceremony. (7/3/02)

Maximum gate fees are \$10.00 Adults, \$5.00 students and 5 and under free. Gate entry charges should be included in pre-meet information. (7/9/03)

Region 8 Committee strongly recommends that judges assigned to Regional Championships wear official NAWGJ uniform and that females wear skirts and men wear ties. (7/9/03)

If a tie for state team occurs at Level 8 Regionals Team competition the tie will not be broken. (7/9/03)

MINI-CONGRESS

The fee for using the Region 8 name for Regional Congress is \$1,000 base fee plus a \$5 per paid registrant in excess of 350 participants charged by Region 8 for hosting Region 8 Congress. (12/19/03)

TRAINING CAMP

The entry fee for the Regional 8/9 and 9/10 training camps is \$130. (7/27/01)

10% of all profits from regional training camps, elite clinics and TOPs testing will be earmarked for regional administrative cost. (6/17/98)

The region will administer as many training camps as needed. The Region will accept bids for a site for all training camps. Level 9's will be offered the option of attending either the 8/9 or the 9/10/E camp. (7/9/03)

TOPS National Team Members from the current or previous year be permitted to register for the Regional 9/10/Elite training camp. (12/16/00)

Petitions will be considered for acceptance to the training camps. Petitions are to be sent to the RTCC and a copy to RJOCC and reviewed under normal Rules & Policies petition guidelines. (6/27/96) (7/9/03)

Level 8 - All Level 8 gymnast who qualify to the State Meet and above are permitted to register for the Level 8/9 Regional Training Camp. (7/9/03)

Level 9 - All Level 9 gymnasts who qualify to the State Meet, but do not qualify to Level 9 Regionals Championships are permitted to register for the Level 8/9 Regional Training Camp. (1/9/99)

Level 9 - All Level 9 gymnasts who qualified to Regionals at State Meet, who competed at Regionals or had petitions accepted to regionals are eligible for the 9/10/E camp. (6/7/00)

Level 10 - All Level 10 gymnasts who qualified to Regionals at State Meet, who competed at Regionals, or had petitions accepted to Regionals are eligible for the 9/10/E camp (6/7/00)

Elite all current Elite gymnasts would be eligible for the 9/10/E camp. (6/27/96)

No fees will be paid for clinician service at training camps. Services will be donated to the region in order to use this as a fund-raiser for the Regional Apparel Fund. (6/27/96)

TOPs

The TOPs Coordinator is authorized to use proceeds of TOPs testing to pay TOPs testers as necessary, up to \$10 an hour, and to reimburse necessary expenses. (6/17/98)

FINANCIAL STATEMENTS

Quarterly financial reports are required. Hard copies of receipts are needed if reports are faxed in. (7/3/02)

Each state chairman should publish financial statements in their newsletters on a regular basis. (7/3/02) (12/20/02)

JUDGING ASSIGNMENTS

Region 8 will use NAWGJ as the regional judging contractor. (6/2/04)

All Judging Availability Forms and In-Gym Cards for regional assignments must be received by the appropriate recipient (RTCC and RJD) by the deadline date to be considered for Regional Assignments (10/10/03)

Judging contracts for Regionals must be received by the deadline indicated on the contract or the contract is void. The RJD will go to the next designated alternate in consultation with the RTCC. (12/19/03)

In unusual gymnastics related circumstances, the Regional Committee delegates last minute assignment decisions to Region 8 JO Committee. (6/2/04)

The number of judging slots received by Region 8 will be filled based on the corresponding number of judges at the top of the judges' rotation. Should a Brevet who would be in a slot eligible for assignment make the decision not to take the assignment, or not judge once assigned, he/she will automatically be dropped to the bottom of the rotation.

Extenuating Circumstances: Should an emergency situation occur and cause the assigned Brevet to miss his/her assignment, the next judge in the rotation will move up. The situation will be presented to the committee to determine if the effected judge takes the rotation slot of the replacement judge or is dropped to the bottom of the rotation.

Should the circumstances occur in which Region 8 received additional slots because a meet is hosted in our region, consideration will be given to assigning National rated officials who are not formally in the rotation but meet the criteria (see below.)

CRITERIA FOR NATIONAL ASSIGNMENTS

- In gym experience per existing regional guidelines every year. (12/20/02)
- Volunteer to teach or work actively with the athletes at least one Region 8 training camp each year. In the case of a valid conflict, a written request for a waiver may be submitted with the Availability Form to Marian Dykes. Requests for waiver will then be submitted to the Regional Committee. Must work one camp the year of assignment and at least one of the three years before. (1/9/99) (12/20/02)
- Actively judging at the Junior Olympic level as required by *Rules and Policies*.
- Judge or coached Regional Championship in the current year and 1 of the 2 prior years. (12/20/02).
- If a judge recommended to Nationals does not judge at Regionals, the committee will replace that judge unless it decides, based on financial considerations, to keep the original judge (6/30/99)
- International judging assignments supersede Region 8 Judges Criteria. (6/2/04)
- If a judge does not satisfy the current elite active-status requirements, they will drop to the bottom of the rotation for Level 10 Nationals and Level 9 Easterns and will therefore be ineligible for that year. (7/27/01)
- If a JO National meet or an Eastern national meet is held in Region 8, at least one judge recommended will reflect representation from hosts geographical area. (6/2/04)
- No more than one-half of the Level 10 National judges recommended from Region 8 will be from the same state. (6/2/04)

PROCEDURE

The Regional Committee will decide upon judges assignments for each national and regional meet independently. Every attempt will be made to assign different judges to Level 10 Nationals and Level 9 Eastern Nationals within each year.

The order is as follows:

- Level 10 Nationals
- Level 9 Easterns
- Level 10 Regionals
- Level 9 Regionals
- Level 8 Regionals (8/21/98)

Judges attending the Level 8/9 Training Camp be permitted to use that to satisfy their clinic attendance requirement for assignment to the following year's regional Level 8 or 9 meet. (1/4/97)

APPAREL

Level 8 State Team to Level 8 Regionals must have a minimum of competitive leotard provided by SACC at no cost to those athletes or their parents. (6/17/98)

10% of all profits from regional training camps, elite clinics and TOPs testing will be earmarked for regional administrative cost. (6/17/98)

Elite athletes competing at an elite Classic or higher competition who did not receive apparel as a J.O.athlete in the same season will receive a full set of Regional apparel. (Elite season from August to August) (12/19/03)

A committee will compile a slate of apparel items. This list will be presented to the gymnasts at Level 9, 10 and Elite Training Camp to vote on their selection. (1/4/97) (7/3/02)

Regional apparel as follows:

1. All athletes competing at an Elite Classic or higher competition or to JO Nationals receive a base set of apparel. Level 9 Eastern National qualifiers will receive apparel as designated. (12/19/03)
2. A club will receive no more than a combined total of three sets or pieces of coach's apparel.
 - a) All clubs that provided one coach who worked at the regional training camps will receive:
 - 1) One set of coach's apparel per Level 10 athlete qualified to Nationals (6/30/99)
 - 2) One piece of coach's apparel per Level 9 athlete qualified to Eastern Nationals (6/30/99)
 - b) All clubs that provided additional coaches to work at any regional training camps will receive one additional set of apparel. (7/9/03)
3. All judges who worked at a regional training camp and are assigned to judge Level 10 JO Nationals or Level 9 Easterns will receive apparel.
4. All clubs that donate \$1,000 or more by State Meet will receive 1 set of apparel only.

RULES & REGULATIONS FOR REGION 8 [Cont'd.]

5. All coaches with qualified athletes may purchase a shirt to wear for competition.
6. Apparel items will be offered for sale.
7. All coaches and judges who have worked camp or donated \$50 will receive a regional shirt.
8. Gymnasts qualified to Nationals who attended Training Camp or who coaches worked camp will receive a bonus pack.
9. Apparel will be provided to the current members of the Regional Committee.

The Sophomore/Junior Information sheets should be placed in each state's newsletters at least once a year. (6/7/00)

ANNUAL REPORT

State Chairmen must submit an annual summary report. Office equipment purchases, the state chair is responsible for sending a copy of the annual equipment form to the RACC by July 10th of each year. (8/21/98) (12/20/02)

STATE COMMITTEE

A list of elected state committees should be sent to the RACC annually. Also a list of all other persons attending State Committee meetings. (8/21/98) (12/20/02)

Any appointed committee member or invited guests to a state or regional board meeting need only participate in a meeting during that portion that pertains to them. (8/21/98)

MISCELLANEOUS
