**Jana Bieger** from *Bieger International Gymnastics* of Deerfield Beach, Florida was very successful at the 2006 World Championships in Aarhus, Denmark. Jana won a team silver medal, nailed her floor exercise routine to clinch the all-around silver medal and finaled on bars and floor, finishing second in the floor exercise.

Jana Bieger was third in the all-around at the Visa Championships, won the vault, placed third on bars and second on beam at the World Cup in Cottbus, Germany, and won the vault and floor titles at the Pacific Alliance Championships earlier this year.

After World's Jana went on to win gold medals on Bars and Floor at the 2006 DTB-Pokal World Cup in Stuttgart, Germany.

## Criteria for Nominations for RACC & RPECC

### CRITERIA FOR NOMINATIONS

All nominees must be:

- Professional Members of the Women's Program at least 21 years old and in good standing for a minimum of two (2) consecutive years immediately prior to the nomination.  
A member in good standing is defined as a person who has complied with all aspects of the program as outlined in the Rules and Policies.
- Special circumstances involving residency criteria for any State or Regional Chairman position can be petitioned to the Regional Administrative Committee (RAC), in consultation with the National Administrative Committee Chairman (NACC), if necessary. Prior to being placed on the ballot, all nominees must sign a document that verifies that they have read and understand the duties and responsibilities of the office for which they have been nominated. If resumes are to be submitted as part of the election process, they will be verified by the election commission that is receiving the nominations.

### REGIONAL ADMINISTRATIVE COMMITTEE CHAIRMAN (RACC)

Must have served for a minimum of two (2) consecutive years as:

1. USA Gymnastics State Administrative Committee Chairman (SACC), or
2. USA Gymnastics Regional Administrative Committee Chairman (RACC), or
3. A National sub-committee member

### REGIONAL PRE- ELITE COMMITTEE CHAIRMAN (RPECC)

1. Must have coached an elite athlete who competed at a Classic or Challenge competition within the last four years.

### ELECTIONS AND TERM OF OFFICE

All nominees for positions must meet the prerequisites in Article V. All positions within the Women's Program Committee shall be elected for specific terms of office, at regularly scheduled intervals.

### REGIONAL OFFICERS

1. Regional Officers - Regional Administrative Committee Chairmen (RACC), Regional Pre-Elite Committee Chairmen (RPECC), Regional Junior Olympic Committee Chairmen (RJOCC), and Regional Technical Committee Chairmen (RTCC) shall be elected by a vote of the Women's Program Professional membership within each Region.
2. Elections for Regional Administrative Committee Chairman (RACC) and Regional Pre-Elite Committee Chairman (RPECC) will be conducted the year before the Olympic Games.
3. Elections for the Regional Junior Olympic Committee Chairman (RJOCC) and Regional Technical Committee Chairman (RTCC) will be conducted 1 year after the Olympic Games.
4. They shall serve for four (4) years.
5. Elections are to be completed by June 1st and term of office begins July 1st.

### Regional Administrative Committee Chairmen / Regional Elite Program Committee Chairman Election Procedures:

Regional Administrative Committee Chairmen and Regional Pre-Elite Committee Chairman are elected by the women's professional members in their respective region. Names of candidates will be announced in February in the following manner:

- Call for Nominations published and/or posted online for a minimum of one month prior to the submission deadline of no later than March 1.
- Each RACC must verify that the nominee meets the criteria for nomination, has agreed to run, understands the job requirements and has submitted a brief résumé (no more than 300 words).

- Each RACC electronically sends to the Women's Program Assistant (RBrazo@usa-gymnastics.org) the name, city and state and the résumé of each candidate (No photos) in a Microsoft Word document NO LATER than March 15<sup>th</sup>.
- If a region does not need to conduct an election because there is only one candidate, that information is also to be sent to the Women's Program Assistant.
- The official Slate of Nominees for each Region will be posted on the USA Gymnastics web-site to begin voting by April 1<sup>st</sup>. The voting will be concluded on April 15<sup>th</sup>.
- The week after April 15<sup>th</sup> the RACC's will receive their respective region's election results by email, including the actual vote counts in the event that any of the candidates wants to know this information. The RACCs will notify all of the candidates of the election results
- If a run-off election is necessary – the Women's Program Assistant will work with the individual RACC on the procedures.

Regional Administrative Committee Chairmen and Regional Pre-Elite Committee Chairman are elected by a majority vote (1 over 50% of votes cast.) If no candidate receives a majority on the first ballot, a run-off election will be held between the 2 candidates receiving the most votes. Run off elections will be announced on the Regional and National websites on March 31st. If a run off election is needed, it will be conducted on the National website.

In the case of a tie in the run-off election, the Regional Administrative Committee will vote to break the tie. If only 1 nomination is received, the National Administrative Committee Chairman/National Pre-Elite Committee Chairman will cast one vote and the nominee will be elected by acclamation.

## DUTIES AND RESPONSIBILITIES

### REGIONAL ADMINISTRATIVE COMMITTEE CHAIRMAN (RACC)

The Regional Administrative Committee Chairman (RACC) is responsible for the overall organization, administration, and finances of the Region. With the help of specialized people, the Regional Administrative Committee Chairman (RACC) develops gymnastics in the region.

1. Be responsible for the overall organization of all regional events.
2. Represent the region as a voting member on the Administrative Committee (AC) and attend any Sub-committee meetings for the Region, as needed.
3. Attend as many events in the region as possible to lend assistance and to evaluate the program.
4. Prepare a written annual report of regional activities and submit this report to the National Administrative Committee Chairman (NACC).
5. Serve as the Women's Program consultant for the region and answer correspondence directed to the regional office.
6. Inform the National Administrative Committee Chairman (NACC) of any major problems.
7. After due investigation, receive recommended corrective measures from the National Administrative Committee Chairman (NACC). Necessary action will then be taken by the National Administrative Committee Chairman (NACC).
8. Actively solicit members to the USA Gymnastics Women's Professional Membership Program.
9. Request the Regional Pre-Elite Committee Chairman (RPECC), Regional Junior Olympic Committee Chairman (RJOCC), to submit reports of their activities.
10. Be responsible to see that all states have a State Administrative Committee Chairman (SACC), either by election or appointment.
11. Prepare and disseminate information to Women's Program Professional Members.
12. Send any materials published in the form of newsletters, etc., by the Regional Administrative Committee Chairman (RACC) to the Senior Director of Women's Program and the National Administrative Committee Chairman (NACC), National Junior Olympic Committee Chairman (NJOCC), National Pre-Elite Committee Chairman (NPECC), and National Technical Committee Chairman (NTCC).
13. Be responsible for:
  - a. conducting regional congress.
  - b. awarding of regional competitions and ordering awards.
  - c. attending all regional meetings and competitions.

- d. providing consultation for the organization of all events.
- e. collecting entry forms for Regional entries into the Junior Olympic East/West and National Championships.
- f. service and recognition awards for the region.
14. Determine the site and meet director for Regional Elite Qualifying meets (or for the Junior Olympic Regional Championships), in conjunction with the Regional Technical Committee Chairman (RTCC) and the Regional Pre-Elite Committee Chairman (RPECC) (or the Regional Junior Olympic Committee Chairman (RJOCC)). Site and directors shall be determined by soliciting bids. The Regional Administrative Committee Chairman (RACC) shall see that these events follow the USA Gymnastics Rules and Policies for competitions.
15. Establish procedures to raise operating funds for the region, if necessary. The Regional Administrative Committee Chairman (RACC) may, with the approval of the Regional Administrative Committee (RAC), determine and/or collect competition and/or club fees for the purpose of raising operating funds for the region. All fees will be retained in the Regional account for use as determined by the Regional Administrative Committee (RAC).
16. Maintain a regional checking account. Within this account, the Regional Administrative Committee Chairman (RACC) shall duly record Regional Pre-Elite Program/TOP, Junior Olympic Program and the regional program funds and disbursements.
17. Follow the reporting procedures on a quarterly basis as outlined in "Financial Reporting Procedures" document.
18. Be responsible for ensuring that the State Administrative Committee Chairmen (SACC) in that Region follow the reporting procedures as outlined in the "Financial Reporting Procedures" document for all State accounts.
19. Keep all receipts, bank statements and cancelled checks for all the accounts of the Region for five (5) years.
20. Be directly responsible to the National Administrative Committee Chairman (NACC).
21. Provided that they have attended a current Test Administrator Workshop, may serve as a Test Administrator for the certification of judges.

## **REGIONAL PRE-ELITE COMMITTEE CHAIRMAN (RPECC)**

1. Attend the meetings of the National Pre-Elite Committee (NPEC).
2. Serve as:
  - a. the chairman of the Regional Pre-Elite Committee (RPEC).
  - b. a member of the Regional Administrative Committee (RAC).
  - c. a member of the Regional Junior Olympic Committee (RJOC).
3. Provide a minimum of one (1) Regional clinic per year for gymnasts and coaches.
4. Assist with the regional clinic/congress and competitions when called upon by the Regional Administrative Committee Chairman (RACC).
5. Submit a financial report to the Regional Administrative Committee Chairman (RACC) for reimbursement of travel, phone and postage expenses.
6. Be prepared to represent the views of the region at annual meetings by the use of surveys and observations.
7. File a written report of regional elite activities/meets with the National Pre-Elite Committee Chairman (NPECC), when requested.
8. Organize and implement the Talent Opportunity Program in the Region.
9. Disseminate information to the Elite community in their region, with the assistance of the Regional Technical Committee Chairman (RTCC) and Regional Administrative Committee Chairman (RACC).
10. Consult with the Regional Technical Committee Chairman (RTCC) to assign judges for Pre-Elite Regional competitions.
11. Submit a written report to the Regional Administrative Committee Chairman (RACC) of their activities in the region. i.e. clinics, training camps, etc.

It is hard to believe that another compulsory season is over and we are in full swing with the optional season. Before you know it, summer will be here and it will be time for Congress, Mini-Congress and of course training camp. Information regarding training camps is included in this newsletter. Please register early, last year both the Level 8 & 9 in July as well as the Level 9-10 Elite camp in October filled up quickly. Optional level coaches please support your region by volunteering to work either or both of these camps. We encourage Brevet and National level judges to also volunteer for these camps. Please remember that these camps are the sole source of income for funding our National apparel and trip. Speaking of our national trip, we are awaiting news from the national office regarding final approval from NCAA. We have been working with the national office to ensure that our national trips will not interfere with NCAA regulations. As soon as details are worked out we will be publishing the information. It is our hope that this trip will finally be a reality this coming June or July.

Once again we are proud to be hosting Level 9 East Nationals in Region 8 and this year is especially exciting with the introduction of regional team competition at Easterns. With this in mind it is so important that we send the message to the rest of the country that we are a united region. ## Non-U.S. Citizens Who Want to Compete in Gymnastics in the United States

A gymnast who is living and training in the United States but is not a U.S. citizen must acquire written approval from the gymnastics federation from his/her respective native country (for which he/she holds a passport) before he/she may compete in competitions held in the United States. If a gymnast who is not a U.S. citizen competes without the written permission from his/her national federation, it is a violation of the International Gymnastics Federation's (FIG) regulations. Getting approval from that federation is the responsibility of the athlete, and this rule applies to all levels of competition in all five programs (men's and women's artistic gymnastics, rhythmic gymnastics, trampoline and tumbling, and acrobatic gymnastics.)

To make it easier, there is a link on USA Gymnastics web site to a draft letter that gymnasts may send to the appropriate national gymnastics federation, as well as a link to the FIG's directory of national gymnastics federations.

## IMPORTANT INFORMATION FOR COACHES OF REGIONAL QUALIFIERS

### REGIONAL MEET ENTRY:

Please be sure that you have **ALL necessary information** at your State Meet to enter your gymnasts in the Regional Meets -- USAG athlete number, birthdate, etc. - and one club check per Regional Meet for entry fees. **No checks from parents are allowed.**

Regional Meet entry fees and forms **MUST** be turned in to your State Chairman (or designated official) at your **State Meet -- within the specified time.**

If a gymnast's Regional Meet entry is **NOT** turned in at the State Meet; in order to enter the gymnast(s) in the Regional Meet the following penalty will apply to the coach:

- a \$200.00 fine payable to Region 8 USA Gymnastics for each meet involved.

PLEASE MAKE SURE THAT YOUR GYMNAST HAS QUALIFIED (according to the **official** announcement of qualifiers) -- AND ENTER HER PROPERLY WITHIN THE SPECIFIED TIME.

### PETITIONS: (No petitions for Level 8 Regionals)

6. **A photocopy of at least one pre-state, sanctioned meet results from the current season (at the level to which they are petitioning) showing a score at least one (1.00) point greater than the regional qualifying score.**
7. A club check for entry fee **MUST** accompany petition to Marian. She will forward check to Meet Director if petition is accepted. (Check will be returned if not accepted or injured gymnast is not release by doctor.)

### AT REGIONALS:

To be allowed onto the floor of competition, all coaches **MUST** wear their **current** USA Gymnastics pro membership card with safety certification expiration date.

Level 9 & 10 coaches - you need to have with you **ALL** necessary information to enter your gymnasts in the National meets - including club checks for entry fees, extra T-shirt purchases, and any JO National apparel that you wish to purchase.

**M**any people in the gymnastics community, especially judges, do not understand the difference between USA Gymnastics and NAWGJ. In addition there is AAU, YMCA, etc. What is this alphabet soup?

**USA Gymnastics (USAG)**—USA Gymnastics is the National Governing Body representing the sport of gymnastics on the US Olympic Committee. USAG develops and runs gymnastics in the United States, from the Junior Olympic level to the Elite level, including the selecting of the USA National Teams. The volunteer committees of the Women's Program of USA Gymnastics produce the Rules and Policies governing competitions. USA Gymnastics working with the Women's Technical Committee has also taken over the certification of judges in the United States.

**National Association of Women's Gymnastics Judges (NAWGJ)**—NAWGJ is the support and service organization for judges in the United States. It provides professional development and education for judges. NAWGJ also serves as a contracting agent for judges for various organizations upon request and provides representation for judges on the various USAG committees in fee structure negotiations. In recent years, NAWGJ has become the primary contact for judges and the NCAA.

### PETITION GUIDELINES

In order to petition to Level 9 or 10 Regional Championships, a completed petition form must be submitted to Marian Dykes. It is the coach's responsibility to get all information needed for the petition. The petition must be **RECEIVED** no later than the Wednesday following the state meet. Please call or fax Marian to notify her that a petition is coming. A check for the petition entry fee must accompany the petition form sent to Marian. If the petition is accepted, Marian will forward the check to the Meet Director.

In order to petition, the coach must:

- complete the petition form (enclosed in this newsletter)
- provide a photocopy of at least one pre-state meet score sheet from the current season or from Regionals, East/West or Nationals of 2006 at the level which the gymnast is petitioning indicating that she has achieved an All-Around score that is a minimum of 1.0 higher than the current regional qualifying score
- a physician's written verification of nature of injury or illness and release to return to gymnastics training
- a written request from the coach or parent
- a check for the entry fee

Qualification to Level 8 Regionals is by placement. Therefore, there are NO petitions to Level 8 Regionals.

### MILEAGE RATE CHANGE

following USAG guidelines, the mileage rate used to reimburse judges for travel changed to \$.48 effective 1/1/07. The mileage rate changes automatically any time the IRS changes the mileage rate. The IRS determines the mileage rate using data compiled by the National Automobile Association on the average cost to operate a vehicle.

Question of the day – Please clarify the compositional requirement for a forward circle or release element:

To be considered a Forward Circle element or Forward release element:

1. Both must go forward around an axis (either the bar or the breadth axis of the body).
2. Check the symbols.
  - a. Many forward circling elements have the small diagonal line at the beginning of the symbol to indicate “forward” Like the clear hip circle forward (Weiler kip), front stalder, pike sole circle forward, etc. Front giants & L-grip front giants have their own forward symbol-upside down U
  - b. Forward release elements are symbolized with a “front salto” symbol, like the Jaegers (on same bar or LB to HB) and Mixed-grip Deltchev (although the downswing is backward giant-the upswing is forward and the salto is forward)
3. Elements that ARE NOT considered forward:
  - a. Gienger/regular Deltchev -symbol & description indicates a backward salto
  - b. Chinese sit-up and other variations like toe-shoot, stalder shoot to HB all stem from a BACKWARD circle and never complete a forward 360° BA turn
  - c. Bail half-shoot over low bar, straddle back to handstand, are all initiated with a backward swing or circle.

In addition there are two compositional deductions referring to pirouettes:

1. Lack of balance between pirouettes and flights: for example a level 10 performs three good release elements but NEVER does any pirouetting in handstand.
2. Lack of elements with LA turn: Does not perform any element that has at least a ½ turn (not necessarily in a handstand position) The above example with three flights and no pirouettes MAY fulfill the LA turn requirement if one of the releases had a turn in it (bail ½, Gienger) If the flight elements were a Tkatchev, a Toe-shoot to HB and a Pak, then both deductions could be applied.

Each experience must be a minimum of 2 hours. The level of gymnasts must be equal to or greater than the level of meet the judge wishes to be considered for. (i.e. Level 9 & 10 Regionals = in gym experience with Level 10 or Elite. Level 8 Regionals = in gym experience with Level 8, 9, 10 or Elite, etc.) Training sessions at a meet may not be used.

A maximum of 3 hours may be completed in a college setting.

A maximum of 3 hours may be from a Regional or National JO or Elite Training Camp. (A training camp may only count for either in gym experience or CPE credit - not both.)

This experience must be an interactive experience; it is not sufficient to sit in the stands and watch workout. Judges must call ahead to schedule gym time. The judge's activities should be under the supervision of the gym's coach.

The judge should keep in mind that the gym club you are visiting is a business. The judges should remain professional and cordial at all times.

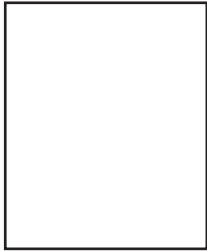

## REGIONAL JO MEET BID INFORMATION

- Level 9 and 10 Meet will have 17 judges including Meet Referee.
- Level 8 Meet will have 17 judges including Meet Referee. There must be 2 judges per state.
- Cost for awards for Level 9 & 10 will be divided between Region and Meet Director. Level 8 is responsible for purchasing awards through the Regional Chairman.
- Meet Director receives entry fees, admissions, concessions, & other sales.
- Meet Director pays judges fees & expenses and any other expenses associated with meet (except ½ awards for Levels 9 & 10).
- Meet Director has responsibility to arrange for equipment contract for the meet and is responsible for this meet expense.
- Meet Director arranges for necessary skill cushion matting and score flashing equipment.
- Meet Director makes hotel arrangements and arrangements for judges transportation.
- Meet Director furnishes room accommodations for Regional officers acting in an official capacity at the meet (RACC, RTCC, RJOCC) - if not already covered as a judge or coach.
- An outside facility (other than a gymnastics business) must be used for JO Regional Meets (high school, college, convention center, city arena, etc.).
- The competitive gym area must accommodate 4 simultaneous events with proper distance and spacing requirements (refer to equipment section in R & P Book). There must be adequate seating for gymnasts and 4 judges per event.
- It is strongly recommended that a separate warm-up area be available. Equipment should be identical to competition equipment. (Floor may be a spring tumbling strip comparable to competition floor exercise mat).
- The spectator area must be adequate to accommodate the families and friends of 132 gymnasts per day. This includes adequate restroom facilities and parking.
- All equipment must meet the specifications as listed in the R & P Book.
- A separate meeting room adequate for 17 officials must be provided with TV & VCR.
- An area for changing clothes/leotards must be provided for the gymnasts.
- An EMT or equivalent personnel should be present at the site and a physician be on call should one be needed.
- Experienced computer scoring personnel is required with electronic score flashing.
- The facility must be air conditioned.
- The hotel should provide facilities and atmosphere conducive to athletes in a competitive situation.
- Facility must be available for open work-out on the day before competition begins.
- Competition fee of \$10.00 per gymnast must be paid to Region 8 USA Gymnastics.
