Shayla scored a 15.575 for her bar routine which featured a Hindorf, toe-on Tkatchev and a double-front dismount. Worley led the United States off on Floor with a solid performance, which included a double Arabian and a front layout, front double full on her tumbling passes and a double pike dismount, to post a 14.625. "It was crazy," said Worley. **Shayla Worley** "We made some mistakes (before floor) but we knew it wasn't too late. It was the most pressure I have ever had in my life, but it felt great to go out and do it. I am very excited for the team." Shayla has just been selected to compete at America Cup March 2nd! **Congratulations Shayla for a great season!**

### State Administrative Committee Chairman ELECTIONS

*Deb Kornegay, RACC*

#### Criterion for Nomination

Nominees must be USAG Women's Program professional members for a minimum of two years in the state program in which they seek election.

Nominees must be at least 21 years old and be members in good standing.

It is strongly recommended that State Committee Chairman candidates have financial skills, organizational skills, communication skills, a working knowledge of the program, and the willingness to fulfill the duties and responsibilities of the position.

Duties and responsibilities of the SACC:

1. The SACC is responsible for the overall organization of the USAG program and events in the state.
2. The SACC provides for the State Administrative Committee, consisting of other members as determined by the state to best serve the needs of the program in the state.
3. The SACC oversees and sets up (in conjunction with the state committee) the following:
  - A. JO Competitions for all Levels
  - B. Sectional or qualifying meets and State Championships
  - C. Qualifying scores and procedures in the state.
  - D. Meet sites for qualifying, Sectional and State meets.
4. The SACC has the responsibility to:
  - A. Support the USAG Women's Program.
  - B. Follow Women's Program Committee rules, policies, procedures, Operating Code, and Code of Ethics.
  - C. Work to assure that the USAG competitions in the state follow the USAG Rules & Policies.
5. The SACC is responsible for helping to keep members informed of important information about the USAG program and about particular dates and items pertinent to the program in the state and region.
  - A. The SACC should publish state newsletters on a periodic basis.
  - B. The SACC should conduct a minimum of 1 annual state meeting of the USAG professional members.
  - C. The SACC serves as the Women's Program Committee consultant for the state and should answer all correspondence directed to him/her.
6. The SACC is accountable for all state USAG funds.
  - A. The SACC is to keep a state checking account in accordance with the established financial procedures.
  - B. The SACC must file quarterly financial reports with the Regional Administrative Committee Chairman and USAG National Financial Officer.
7. The SACC is a member of the Regional Administrative Committee.
  - A. The SACC is expected to attend the meetings of the Regional Administrative Committee.
  - B. The SACC is directly responsible to the RACC and should work closely with all of the Regional personnel.

### ELECTION PROCEDURE

State Administrative Committee Chairmen are elected by the women's professional members in their respective states. Names of candidates will be announced in February in the following manner:

State Administrative Committee Chairmen (SACC) shall be elected by the Professional members of the Women's Program in their respective states. They shall serve for two (2) years and be elected in the spring on even numbered years. Elections to be completed by April 15th. Term of office to begin July 1st. Regional Administrative Committee Chairmen (RACC) shall solicit nominations from the regional Professional membership through the regional newsletters and websites. All nominees who are eligible candidates for each office will be placed on the online ballot. A call for nominations must be published and/or posted online for a minimum of one month prior to the submission deadline of no later than March 1.

The following statement will be placed on the USA Gymnastics national website and emailed to all Women's Professional Members who have current email addresses. Each Region and State should post it on their web-sites so that the Professional members are aware of the voting procedures and their responsibilities to ensure that their vote will be counted. Elections will be conducted on-line at [www.usa-gymnastics.org](http://www.usa-gymnastics.org) from April 1 – April 15. In order to ensure that your vote can be counted, each Professional Members should make sure of each of the following:

1. That their address is current (specifically the State)
2. That they know their personal User ID (which is their Professional Member number)
3. That they know their password (a Professional Members password is their eight digit date of birth in a MMDDYYYY format unless they have otherwise instructed.)
4. Their Professional membership, safety certification and background check, if necessary, must be fully processed and current by February 28.

In addition to the implementation of the new J.O. Committee, you can look for the following changes in the Regional Junior Olympic landscape:

### New Training Camp System

After much communication and question asking, I proposed a new three camp system to the Regional Board in December and it was adopted. The new camp system will begin in July and include the following camp experiences:

1 = "Regional Team" Training Camp – July 25-27, 2008 at Gymnastics Inc. - SC

#### Qualifiers:

Level 8 State "Regional" Team athletes (up to 64)

Level 8 Regional athletes that placed 1-3 at Regional Championships in non state team sessions.

TOP's National Qualifiers that competed L 7 and above in the previous year.

2 = “R 8 National Team” Training Camp – September 12-14, 2008 at GAA in Atlanta

Qualifiers:

All L 9 and 10 athletes that qualified to the previous year's Eastern/National Meet

All active elite athletes

This camp will serve as host for NAWGJ Symposium

3 = “L 8, 9, 10 Regional Training Camp” - October 3-5 at ACE in Florida

Qualifiers:

All L 8, 9 and 10 athletes that qualified to the previous year's Regional Championship meet or above.

I am confident that the new camp system we have put in place will provide the ultimate training and learning opportunities for our athletes, coaches and judges alike and help take Region 8 to the next level. With that said, however, the training camps cannot be a success without the support of our clubs. I would ask every club that qualifies athletes to Level 8-10 Regional Championships be a part of at least one of the three camps, as all of the funds raised go directly back to our athletes and coaches for apparel and our “All-Star” trip. Please do your part.

Another item that is very important to me and the Region 8 J.O. Committee is improved camaraderie and **team building** at our Championship meets. Below are my ideas on how to maximize Region 8's sense of team and oneness.

First of all, I am going to book a block of rooms at a local hotel at both Easterns and Nationals to be used as the Region 8 “Host” hotel. Detailed information will be distributed to our Eastern and National qualifiers, their families, and their coaches at Regionals. We are going to recommend that every R 8 parent and coach book their reservations in this particular hotel. I really feel that this is going to be a great step in team building and a feeling of togetherness.

I am also going to have a couple of meetings at the championship events to introduce the athletes to their teammates, hand out apparel, and to go over workout and march-in procedures. I hope that everyone will make a concerted attempt to attend. I really want to see everyone on the same page at these championships so that we can provide the ultimate feeling of camaraderie for the athletes of Region 8.

Finally, I want to give specifics on how the **Regional “All-Star” team** was selected in 2007 and will be selected in 2008. The top six – L 9's (plus ties) and the top six – L 10's (plus ties) from Eastern/National Championships will make up the team. The team is chosen as follows:

Any athlete(s) that place(s) first in the AA get first priority.

Any athlete(s) that place(s) second in the AA fill any remaining spots.

Any athlete(s) that place(s) third in the AA fill any remaining spots.

If there are still spots available the athlete(s) with the highest AA score, regardless of age group, will make up the remainder of the team.

Due to NCAA regulations, graduating seniors are ineligible for the trip.

Details on location, dates, and times will be available shortly following JO Nationals.

I really hope that everyone will be receptive to my ideas and will be supportive in this time of change. I really want to see Region 8 be all that it can be.

As a new optional season starts, the membership needs to be reminded of several updates and changes.

## Petition guidelines:

- In order to petition to the Level 9 or 10 Regional Championships, the coach must provide a photocopy of a least one pre-state meet score from the current season (at the level to which the gymnast is petitioning) indicating that she has achieved an All-Around score that is a minimum of 35.00 AA. If the gymnast competed in the previous year's Regional, East/West or National meet, she may submit that All-Around score, provided that it is a minimum of 35.00 AA and is also at the level to which the gymnast is petitioning.
- Petitions for Regionals should be mailed to Marian Dykes – it is the coaches responsibility to get all information needed for the petition. The petition must be received no later than the Wednesday following the state meet. Please call or FAX Marian to notify her that a petition is coming. A check for the entry fee must accompany the petition sent to Marian. If the petition is accepted, Marian will forward the check to the Meet Director.

## 2008 Updates

### Judges' Meetings prior to competition (all levels)

Judges /Meet Referees are reminded that the following procedures should be considered for inclusion during the meeting prior to competition:

1. logistics of the meet/scoring system, meet mechanics, etc.
2. rule changes
3. equipment issues
4. info from Meet Director
5. professional protocol reminders

### Official Score sheets

Per the R&P page 64. B.4. the judges are not required to sign the official score sheets. The Chief Judge checks that the scores of all judges, the average score, as well as time and line violations are properly recorded during the competition.

### Determination of Final Event Score - R & P Page 10.D.

Clarification: The procedure of using the score of the Chief Judge or Meet Referee to average with

the original average score of the two judges (Base score) is NO LONGER USED.

It is the professional responsibility of the judges to come to an agreement if their scores are initially out of range. If the judges are unable to compromise, the Chief Judge may mandate that the scores be brought into the allowable range.

## **Inquiries**

Reminder to judges: if a coach has a question regarding an exercise during the competition, the judges should advise the coach to submit an Inquiry Form to officially receive information. There should be no casual conversation regarding the evaluation of an exercise between a coach and a judge during the competition.

## **Affiliation - R & P, Page 63:**

Affiliation of an official at a specific meet refers to:

- An immediate family member is defined as a parent/step-parent, grandparent, sibling or any member of the household.
- A judge who is an immediate family member of a competing gymnast, or of a coach or club owner of a competing team, is considered affiliated with that specific club team and may not be assigned as a Chief Judge at meets in which that club is competing.

Refer to Rules and Policies, page 63, II.B: In non-qualifying Open Invitationals with two or four judge panels, affiliated judges may be assigned as Chief or Panel Judges, provided that the Meet Director lists the judges and their affiliation on the pre-meet information.

## **Start Value**

Since the flashing of Start Values is now required, it is the responsibility of the meet director to insure that Start Value flashers are provided for each judge, unless the Start Values are to be written on the gymnast's competitor card.

## **Judges' Accreditation**

Clarifications regarding procedures:

- Former judges who have no current rating may start testing again at the level they previously held.
- Judges who hold a current foreign Brevet and are now living in the U.S. will be required to submit documentation of their Brevet and attend a Level 10 Optional judging/rules clinic prior to being assigned to a Jr. Olympic meet. A person who held a foreign Brevet in the past, but does not hold a current Brevet rating, may begin testing at Level 10.
- All Optional-rated officials must test at Level 5/6 in order to judge at the Compulsory levels.
- CPE deficient: If there is a need to assign a judge who has not completed their CPE, the assignor must inform the meet referee, so that the specific judge's fee will be reduced by \$5.00 per hour as (per the Rules and Policies, page 66, A. 9. c.2).
- When hosting a clinic, it is the clinic organizer's responsibility to have staff available, in addition to the clinician, to sign the CPE forms. Reminder that for multi-track clinics (like Regional Congress), only sessions that pertain to coaching and/or judging of competitive gymnastics can be used for CPE hours. It was suggested to designate the CPE-eligible sessions by an asterisk and to title the judging/coaching tracks as Women's Artistic, rather than judges/coaches.

## Courses for 2009

- Level 10 Re-certification was discussed and a decision was made to discontinue this level of certification. All individuals attempting to attain the Level 10 rating must successfully pass the Level 10 Theoretical and Practical exams at 80% on each part.
- National Course (multiple dates)
  - Eligibility:
    1. Current Brevet or National rating
    2. Held a Level 10 rating a minimum of two complete cycles (8 years)
    3. Must have attended a minimum of two USAG Regional or National Congresses or National NAWGJ Symposium in the current cycle (June 2005 – Dec. 31, 2008).
    4. Must hold a current USAG Professional membership and current safety certification
    5. Must be current with CPE requirements

### Format:

Written Exam (10 questions on general and each event)

Practical exam (5 routines per event)

### Criteria for attaining a National rating:

- 85% average with a minimum of 80% on each part (Written/Practical)
- If a judge scores a minimum of 80% on each part, but does not achieve an 85% total\*, he/she will receive a Level 10 rating.
- Anyone scoring below 80% on either part must either take the National Course re-test or take the Level 10 exam.

\* A one time National Course re-test will be offered at the National Congress

### - USAG BREVET COURSE

#### Eligibility:

1. Current FIG or USAG Brevet
2. Previous Senior National (Elite) team member (minimum of 21 yrs. of age)
3. Current USAG Professional membership and safety certification
4. Current with CPE requirements

Course format/criteria for passing will be determined at a later date.

Each experience must be a minimum of 2 hours. The level of gymnasts must be equal to or greater than the level of meet the judge wishes to be considered for. (i.e. Level 9 & 10 Regionals = in-gym experience with Level 10 or Elite. Level 8 Regionals = in gym experience with Level 8, 9, 10 or Elite, etc.)

Training sessions at an Elite National Qualifier competition or above meet may be used. Training sessions at Elite Regional or J.O. competition may not be used.

Division 1 NCAA in-gym training is allowed and considered comparable to Level 10.

Hours may be from a Regional or National JO or Elite Training Camp. (A training camp may only count for either in-gym experience or CPE credit - can not be simultaneous .)

This experience must be an interactive experience; it is not sufficient to sit in the stands and watch workout. Judges must call ahead to schedule gym time. The judge s activities should be under the supervision of the gym s coach.

### REGIONAL MEET ENTRY:

Please be sure that you have **ALL necessary information** at your State Meet to enter your gymnasts in the Regional Meets -- USAG athlete number, birthdate, etc. - and one club check per Regional Meet for entry fees. **No checks from parents are allowed.**

Regional Meet entry fees and forms **MUST** be turned in to your State Chairman (or designated official) at your **State Meet -- within the specified time.**

If a gymnast's Regional Meet entry is **NOT** turned in at the State Meet; in order to enter the gymnast(s) in the Regional Meet the following penalty will apply to the coach:

- a \$25.00 late fee per gymnast (in addition to the regular entry fee) must be paid to the Regional Meet Director
- a \$200.00 fine payable to Region 8 USA Gymnastics for each meet involved.

PLEASE MAKE SURE THAT YOUR GYMNAST HAS QUALIFIED (according to the **official** announcement of qualifiers) -- AND ENTER HER PROPERLY WITHIN THE SPECIFIED TIME.

### PETITIONS: (No petitions for Level 8 Regionals)

1. Any petitions should be mailed to the RTC, Marian Dykes -- it is YOUR responsibility to get all information needed for petitions.
2. Marian must RECEIVE petition NO LATER THAN **WEDNESDAY** following State Meet.

7. A club check for entry fee **MUST** accompany petition to Marian. She will forward check to Meet Director if petition is accepted. (Check will be returned if not accepted or injured gymnast is not release by doctor.)

### AT REGIONALS:

To be allowed onto the floor of competition, all coaches **MUST** wear their **current** USA Gymnastics pro membership card with safety certification expiration date.

Brad Harris, newly elected Regional Junior Olympic Committee Chairperson, was introduced.

A group picture was taken.

Jennie Adams was appointed secretary.

Thank you notes received from membership were circulated.

Updated list of Board addresses and information was circulated for approval.

Deb K presented a sheet with corrected dates for the Region 8 USA Gymnastics planner. Of Region 8 interest are the following:

Deb K presented Region 8 and Regional event financial statements. The financial return from Regional Congress will be coming soon from USAG national office as well as corrected rebates for each state's account. Problems with the national USAG database for professional memberships and athlete membership continue to improve.

Deb K presented an update on Region 8's Hurricane Fund. \$600 remains in the fund, but the account is being charged a monthly fee. It was suggested to use money from another regional fund to increase the Hurricane Fund to a large enough amount to eliminate the fee. A general discussion suggested that the fund be renamed and "Emergency Fund," but no action was taken. Jackie L. will check in LA to see if there are additional individual or club needs.

Deb K reminded Regional officers of the early January deadline for newsletter articles.

Deb K explained that all 2008 9/10 Regionals hotel rooms must go through one booking agent. The hotel request form will be in the January newsletter. Deb explained past Regional Board apparel responsibilities. Brad had suggestions for new procedures. His Tampa Bay Turner staff has promised to be supportive. He also suggested that there be a pre-workout meeting at Nationals w/ coaches for Regional apparel distribution.

Deb K reminded the Board that Level 8 Regionals State Team rules concerning an injured athlete are the same as Easterns. (The injured athlete would move to become an all star, and the first alternate would move into the team). The Level 8 Meet Director asked for guidance in providing a banquet or social. Deb W suggested offering a hospitality room during the workout sessions. Mike Mc. suggested distributing local coupons. Brad H. suggested that states have alternate apparel available.

Deb K. reminded the Board that a team consists of 8 gymnasts, but 4 will count toward team score.

The Committee discussion reaffirmed that the Level 8 all-star alternate rule will be followed – Alternates will be placed in any slots that become available up to forty-eight hours prior to the start of warm-ups of the first session of competition. (12-14-07)

Deb K reminded everyone that the Level 10 Nationals would be in Kissimmee. State Chairs shall take care of gifts for visiting officials, to be shipped to Mike Mc, who will transport to meet for assembly.

Because frequent regional events are to be held in Florida, (Regional Congress for two consecutive years in Jacksonville, etc.), Mike Mc asked for consideration in his ability to provide viable state educational fundraisers from FL- USAG account. Discussion followed but no resolution.

A discussion ensued on whether to have a banquet, another gathering, auction, etc. for the social/fundraiser at Region 8 Congress. If another auction were planned, states are encouraged to contribute approximately \$1,000 for the auction.

Deb K announced that the Regional Board should plan to meet at Regional Congress 2008 Thurs., July 17th at 9:00 am.

June 12 - 14, 2009 is the date for Regional Congress in Jacksonville, Fla.

Deb K distributed a finance/expense report from '07 Region 8 Congress. Suggestions were given concerning motivational speakers, informational speakers, or instructional speakers. (Jon Gordon of Jacksonville, FL & Jeff Lulla). It was also requested that the lecture room size and accommodations for judging sessions be enlarged at '08 Regional Congress

Marian D handed out a proposal for selection criteria for the Region 8 Hall of Fame. Extended discussion followed.

Nominations for 2008 Hall of Fame Class. Nominees had either trained or lived in Region 8 and were named to Olympic team.

Toni R reported on the Tim Rand Memorial Fund. Toni would like for the fund to be continued. She asked that the officers of the Board help determine how the money would be distributed. Toni will match raised funds up to \$5000. Toni suggested that the funds be used for coach education, athlete support, or wherever the need is for each year.

A pin and charm, developed by A-1 Awards, that might be placed on a medal at an invitational or State Meet was passed around for inspection.

Marian D opened a discussion on the Region 8 Judging Assignment criteria. Because costs are truly becoming prohibitive for judges' education, Marian requested that a 2-year extension on the requirements of the guideline be implemented.

Motion to amend the criteria for National judging assignments to include that a volunteer may work actively, teach, or **host** at least one Region 8 training camp **every other** year.

Motion: Brad Harris

Second: Marian Dykes

**PASSED unanimously**

In order to double check that criteria for judging assignments are being appropriately and relevantly applied, Marian suggested that each state chair re-analyze the criteria and make suggestions for changes. She reaffirmed that she will first check with state judging directors and state chairs to clarify any questions.

Brad H presented his first Regional JO Program report. He created a working Region 8 JO Committee expressing the rationale that the region needs informal communication with representatives from each state so that each state will always have a voice. Brad plans to use the representatives to help bring ideas from each state to the National JO Committee.

In regards to Regional apparel, Brad wants the apparel to be what the athletes need, not necessarily what they want. He would like to have the athletes from the region have the appearance of a unified team on the workout day and whenever walking out onto the floor at Easterns or Nationals. The GK apparel would be given out later at the competition site.

Brad presented to the Board:

Samples of warm-up suits

Large draw-string gym bags (donated by Brad's gym this year in T. Rand's name)

Small Grip bag (donated by Cindy Pokrana – Busy Bodies in T. Rand's name)

Flip-flops provided by 10.0 basically at cost

T-shirts for under the warm-up suit and tank tops

And something to wear to the banquet so they'll look like a team there also.

The cost will be about roughly \$60 for each gymnast w/ the tank top; \$50 without the tank top.

Level 9's would only receive a tank leotard as restricted by National USAG regulations.

Written instructions will be given to coaches and gymnasts for when to wear what item.

Coaching apparel would include:

Warm-up jacket w/ embroidery (about \$50 each). Coaches would supply own black pants.

Coaches' shirts – work-out shirt – T-shirt w/ logo. (\$3.75 each)

Dry-wick T-shirt with embroidery. (\$15-\$18)

All coaches receive apparel whether they worked training camp or not.

Coaches would be encouraged to wear regional apparel at National meets .

Coaches would be encouraged to support Training Camps by sending to the camp either gymnasts or coaches, or both gymnasts and coaches. Specific support will be rewarded to the gymnasts from the participating program.

Brad will check on the cost of including the receipt of a warm-up jacket by the Level 9 coaches with gymnasts who have qualified to Easterns. Specific criteria will be created for the number of Level 9 coaches from a team who would receive the jacket. When a coach picks up apparel, each must sign a commitment of the number of team coaches going to Nationals. (If a coach is not going to Nationals, he/she would not receive apparel.)

Motion to accept the Region 8 Athlete Fund apparel distribution procedures be updated as presented.

Brad shall revise the Regional Apparel forms to reflect the changes in the discussions.

Brad discussed the concerns from the previous training camps:

Level of quality – coaching and instruction – has decreased.

Motion to accept proposal to have a new training camp with a new level of expertise (any level 9 or 10 who qualified to the previous Easterns or Nationals). The Master staff would be assembled by Brad. This would be the best skill level of camp to work in conjunction with NAWGJ symposium.

Reserve spots by % of qualifiers at Nationals by a certain date, then open up to first- come-first-served basis, up to 100 gymnasts.

TOPS National qualifiers should be invited to the Level 8 training camp.

Toni suggested having a few “paid” clinicians for the September Training Camp. It was also suggested that the July camp be called Regional Team Camp.

Brad H proposed the idea of a State Developmental Clinic, bringing regional clinicians to the individual state clinics, to improve the quality of compulsories, perhaps becoming a biannual opportunity. It would be a good educational opportunity. A fee would be charged for the gymnasts (level 4-7) and the coaches, but the proceeds could go to the State and to the Region. \$75 and \$50 would be reasonable amount for fees. It would also serve as a great memorial to Tim Rand. The host state would share in the administrative duties. Marian would like to have the judging community included as clinicians. It was suggested that the athlete participants be limited to 80 gymnasts or so.

The National JO Committee voted to continue a National Coach of the Year. Region 8 will vote for a Regional Coach of the Year at Regionals as we did last year. Each state was encouraged to continue with own procedure. Each state's nominee must be presented to Region 8 Committee at Level 9 & 10 Regionals.

Brad will set up a Region 8 Host Hotel for Easterns and Nationals in order to better develop a tighter team concept. He will invite everyone to a meeting before the Regional workout where they'll receive apparel and listen to a "fire-up" speech.

Clarifications about the Region 8 All-Star trip were stated. Graduating seniors are ineligible for the trip. The selection criteria for the trip shall be: The top six gymnasts – L9's (plus ties) and the top six – L 10's (plus

ties) from Eastern/National Championships will make up the team.

Deb K stated that the State Chairperson's 4th quarter financial statements are due on Jan. 15, 2008.

State Chairs should pay the individual state's Regional competition fees to Deb before the end of the meeting.

The Regional reporting process had not changed and Deb went over the process. Deb K distributed the necessary information needed to give to coaches at individual state meets.

Deb K reminded State Chairs:

1) of the need to e-mail number of 9's & 10's at 34 and 8's at a 30 and at 34 by noon on St. Patrick's Day, March 17, 2008.

2) that distribution of Achievement Awards for Levels 4 and 5 State Meets were still required

3) that State Chairs (SACC's) should decide whether each would run again for the Chair's position and relay it to the State Board early in 2008.

Toni R reported that there are some changes in the Elite and TOPS program, but these would be available at the Elite clinic @ Metro later this weekend.

Marian D reported that the Technical Committee met and spent time streamlining the Regional Congress process. In order to have informational equity in each Region, the committee is working to create the same core of lectures, providing more uniformity of clinics throughout the nation.

Marian stated that the 2009 Tech 9/10 Training video is available.

Marian stated that new judging course dates are to come. The criteria for the National course are out and Marian will be asking for feedback. Everyone will be required to test. There will be no level 10 recertifications.

Deb K relayed the dates and times for meetings at National Congress in Philadelphia, PA.

·Women's Program Appreciation Lunch will be on Thursday, June 19, 2008.

·The State/Regional Administrative Chairman workshop will be on Sunday, June 22, 2008.

## REGIONAL JO MEET BID INFORMATION

- Level 9 and 10 Meet will have 17 judges, including Meet Referee.
- Level 8 Meet will have 17 judges, including Meet Referee. There must be 2 judges per state.
- Cost for awards for Level 9 & 10 will be divided between Region and Meet Director. Level 8 is responsible for purchasing awards through the Regional Chairman.
- Meet Director receives entry fees, admissions, concessions, & other sales.
- Meet Director pays judges fees & expenses and any other expenses associated with meet (except ½ awards for Levels 9 & 10).
- Meet Director has responsibility to arrange for equipment contract for the meet and is responsible for this meet expense.
- Meet Director arranges for necessary skill cushion matting and score flashing equipment.
- Meet Director makes hotel arrangements and arrangements for judges transportation.
- Meet Director furnishes room accommodations for Regional officers acting in an official capacity at the meet (RACC, RTCC, RJOCC) - if not already covered as a judge or coach.
- An outside facility (other than a gymnastics business) must be used for JO Regional Meets (high school, college, convention center, city arena, etc.).
- The competitive gym area must accommodate 4 simultaneous events with proper distance and spacing requirements (refer to equipment section in R & P Book). There must be adequate seating for gymnasts and 4 judges per event.
- It is strongly recommended that a separate warm-up area be available. Equipment should be identical to competition equipment. (Floor may be a spring tumbling strip comparable to competition floor exercise mat).
- The spectator area must be adequate to accommodate the families and friends of 132 gymnasts per day. This includes adequate restroom facilities and parking.
- All equipment must meet the specifications as listed in the R & P Book.
- A separate meeting room adequate for 17 officials must be provided with TV & VCR.
- An area for changing clothes/leotards must be provided for the gymnasts.
- An EMT or equivalent personnel should be present at the site and a physician be on call should one be needed.
- Experienced computer scoring personnel is required with electronic score flashing.
- The facility must be air conditioned.
- The hotel should provide facilities and atmosphere conducive to athletes in a competitive situation.
- Facility must be available for open work-out on the day before competition begins.
- Competition fee of \$10.00 per gymnast must be paid to Region 8 USA Gymnastics.

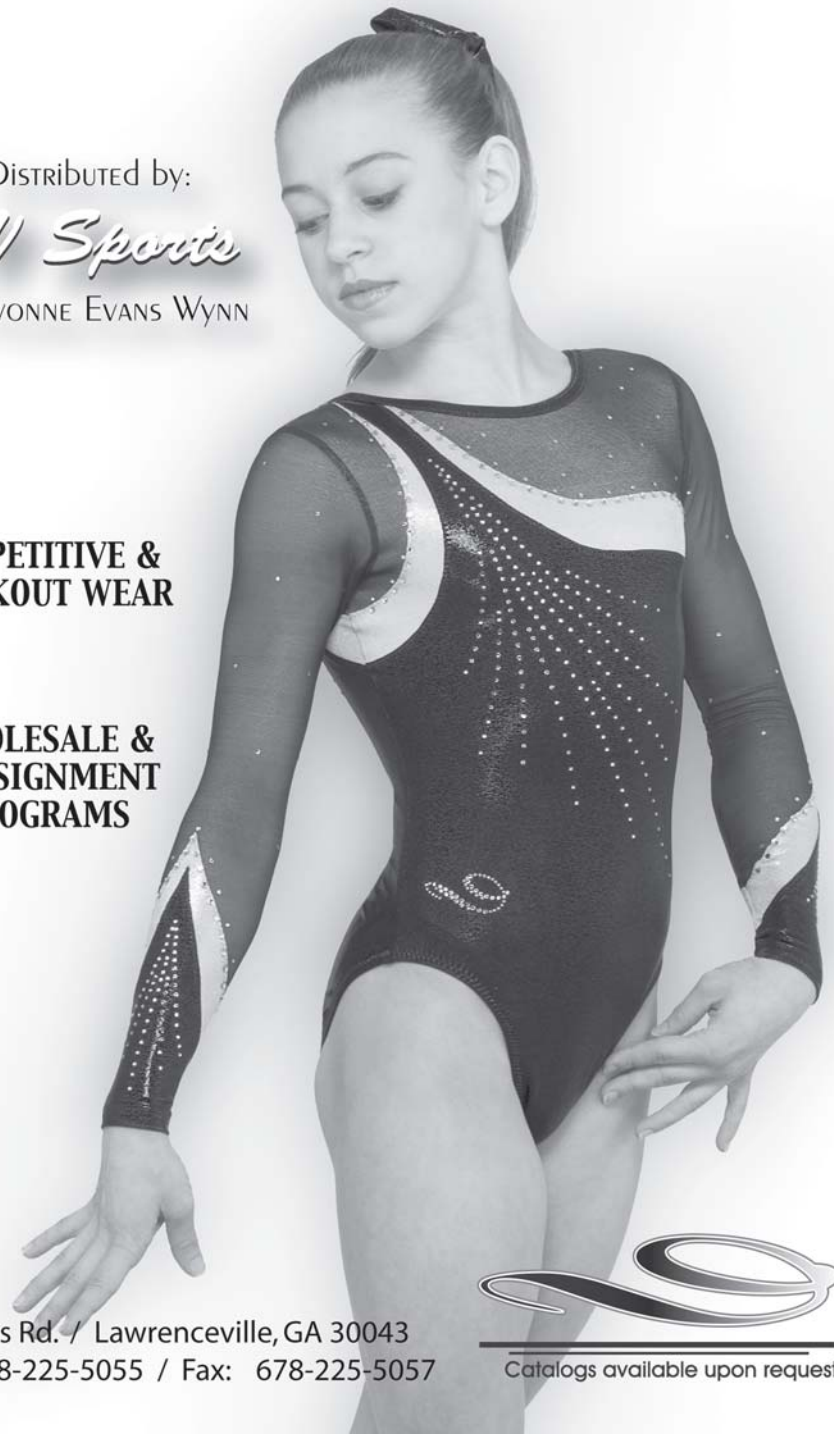

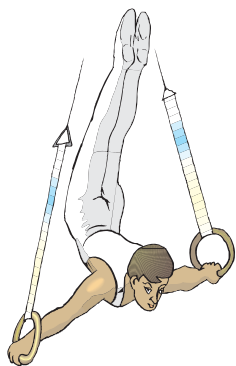

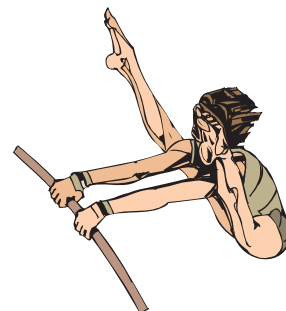
